The U.S. offshore wind market has surged in growth over the last few years, bolstered by the U.S. government's commitment in 2021 to increase offshore wind lease capacity as well as the Biden Administration's declaration that the United States will commit to achieving net zero by 2050. At the same time, the focus in offshore wind has widened to include the Eastern Seaboard, the Gulf of Mexico, and the West Coast. This expansion has been due, in part, to state action, for example, California's enactment of AB 525 in September 2021, which mandated that the California Energy Commission create a plan for offshore wind development in federal waters, and Oregon's HB 3375, which created a task force to achieve 3GW of offshore wind by 2030. Of course, American progress follows banner years in Europe, which provide useful instruction and lessons learned. The 2022 Offshore Wind Handbook explores these topics and more, and outlines some of the challenges and key issues facing the market to help investors and developers build a leading position in the U.S. offshore wind market.
