REPRESENTATIVE EXPERIENCE

- In one of the most legally significant and high-profile cases involving the State of Qatar, representing a private citizen based in Lebanon who (along with a total of 18 Qatari Defendants) is accused of conspiring, under the direction of senior figures within the State of Qatar, to fund terrorism in Syria. Successfully represented the Defendant in the High Court, where the judge rejected the case on state immunity grounds (under the State Immunity Act 1978), agreeing with our (and the other Defendants') arguments on state immunity on all counts. The judge also awarded our client its costs. The Claimant has sought permission to appeal to the Court of Appeal in England.
- Acting for the Claimant, a commodity trading and mining company, in an LCIA Arbitration concerning a contractual dispute.
