OVERVIEW

His representations involve a wide range of competition issues, including price-fixing, bid-rigging, market/customer allocation, no-poach/no-hire agreements, monopolization, attempted monopolization, market manipulation, unfair competition, and other restraints of trade.

Brian has conducted numerous domestic and global internal investigations for major corporations across a variety of industries. He regularly defends corporations and individuals who are subjects of federal and state grand jury subpoenas, cross-border investigations, and enforcement proceedings.

Brian also advises clients on the antitrust aspects of mergers, acquisitions, and joint ventures. He has helped guide clients through U.S. merger clearance, and advises on antitrust issues related to both horizontal and vertical mergers, gun-jumping, and pre-merger due diligence and integration planning.
