As Deputy Director in the WHD, he was one of a small management team responsible for the economic monitoring and the provision of macro-economic advice to IMF member countries in Latin America and the Caribbean. Governor Williams was the main architect of the Caribbean Regional Technical Assistance Agency (CARTAC), which was the precursor to similar training institutions that were subsequently established in Africa and other parts of the world. He holds a M.Sc. in Economics and a B.Sc. in Economics (Upper Second Class Honors) from the University of the West Indies.
