The Courts

Our lawyers in Dubai are registered to practice before the Dubai International Financial Centre (DIFC) courts and have full rights of audiences and represent parties before the English-language common law courts of the DIFC. In Qatar, our lawyers have full rights of audience in the Qatar International Court and Dispute Resolution Centre. We also regularly offer advice regarding Dubai International Financial Centre and Qatar Financial Centre law and regulatory matters.

The Middle East offices have established relationships with leading local lawyers throughout the region and can effectively supervise and manage litigation in the local courts across the jurisdictions of the Middle East and North Africa, as well as manage arbitrations arising out of disputes within the region.

Antibribery and Sanctions

International businesses are also facing greater scrutiny as a result of legislation such as the U.S. Foreign Corrupt Practices Act (FCPA), the UK's Bribery Act, and similar laws enacted by signatories to the OECD Convention Combating Bribery in International Business Transactions as well as an array of sanctions regimes and trade restrictions initiated by authorities in the United States, the European Union, and the United Nations. With the increase in enforcement of anticorruption and sanction laws, it is critical that companies are in a position to make intelligent, risk-based decisions.
