### **OVERVIEW**

Nominated as one of Coindesk's Most Influential People in Blockchain in 2017, Andrew "Drew" Hinkes is a partner in the firm's Payments, Banking Regulation, and Consumer Financial Services group and co-chair of the firm's Digital Assets industry group. A noted trailblazer in the digital assets legal world, Drew's practice covers both domestic and cross-border matters. Drew has advised diverse clients ranging from startups to multinational regulated businesses regarding securities regulation, payment systems, token distributions, money services business and money transmitter regulation, lending and staking, secured transactions including digital asset collateral, structuring and governance of DeFi protocols and applications, Decentralized Autonomous Organizations (i.e. DAOs) and similar decentralized entities, anti-money laundering compliance, non-fungible tokens (NFTs), stablecoins, and other related technologies. Drew's practice includes litigation of issues of first impression related to digital assets, counseling clients as to risks related to new products and services including digital assets, and drafting agreements for digital asset-related services and products.

Drew's contributions to the law of digital assets go far beyond his representation of clients. From 2018-2022, Drew was an Adviser to the Uniform Law Commission as part of its study of digital assets, and later, as part of its drafting revisions to the Uniform Commercial Code, culminating in the publication of the 2022 Amendments to the Uniform Commercial Code, including new Article 12 which incorporates digital assets into the UCC as controllable electronic records. Drew is also an Observer to the UNIDROIT Working Group on Digital Assets and Private Law where he has participated in the study and drafting of principles of law related to digital assets and private law. Drew has also advised the Law Commission of England and Wales on issues related to DAOs. Drew is also the Co-Chair of the American Bar Association Business Section Uniform Commercial Code Emerging Technologies Subcommittee.

Drew also helps to train the next generation of lawyers tackling complex legal questions related to digital assets as an Adjunct Associate Professor at New York University Stern School of Business and an Adjunct Professor of Law at the NYU School of Law, where Drew has co-taught "Digital Currency, Blockchains and the Future of the Financial Services Industry" to JD/MBA students since 2018, and taught Governance of Bitcoin and Cryptocurrency Systems to students in the NYU Master of Science in Cybersecurity Risk and Strategy program. Drew was also appointed as a lecturer at Externado Universidad de Colombia, based in Bogota, Colombia where he taught a comparative international crypto regulation class. Drew has delivered lectures related to digital assets at universities on 4 continents (including University of Chicago, NYU, University of Pennsylvania, UCLA,

Northwestern, Externado Universidad de Colombia, Max Planck Institute for Procedural Law and Singapore Management University). Drew is a frequent speaker and writer on topics related to digital assets, with a particular focus on decentralized ventures, insolvency and digital assets, and regulation of digital assets, and is frequently quoted for his insights into digital assets and regulation, including quotes by the New York Times, Bloomberg, American Banker, MIT Technology Review, Time Magazine, Barrons, and Coindesk, among others. In 2020, Drew co-authored a textbook, "Digital Assets and Blockchain Technology: U.S. Law and Regulation," which is widely used to teach the regulation of digital assets at law schools around the world.
