OVERVIEW

Bill Shaw's primary area of practice is complex civil litigation, in both state and federal courts. He has extensive jury trial experience in Washington state and federal courts. Bill handles a wide variety of litigation matters, including significant patent, trademark, intellectual property and trade secrets issues, legal malpractice, general commercial disputes, white collar crime, products liability and toxic torts, and environmental litigation and arbitration.
