### **OVERVIEW**

Prior to working in the governor's office, Rene served as Director of Legislative Affairs for the Pennsylvania Department of Revenue. During her tenure as Legislative Director, and prior to that, as Assistant Legislative Director, she advocated for legislative priorities related to taxation and the Pennsylvania Lottery, including significant business tax reform packages that dramatically changed state tax administration and tax compliance.

Before joining the Department of Revenue, Rene worked in a senior staff capacity for the House Democratic Caucus. Her responsibilities included monitoring House floor activities and advising House Democratic Leadership in message development and legislative strategy.
