### OVERVIEW

In this capacity, he has successfully litigated claims involving multi-million dollar damages resulting from catastrophic injuries. These cases routinely involve litigation focused on agency and/or dangerous instrumentality doctrine.

Josh also has significant experience representing clients in construction and energy disputes, including the defense of major roadway construction contractors in conjunction with the building of a major interstate highway, and multiple successful arbitrations related to the construction and installation of solar panels.
